RESOLUTION NO. 1046 -2020, ADOPTING THE 2020 SUFFOLK COUNTY MULTI-JURISDICTIONAL PRE-DISASTER HAZARD MITIGATION PLAN APPROVED BY FEMA ON DECEMBER 4, 2020 PENDING LOCAL ADOPTION, WHICH WAS PREPARED IN CONJUNCTION WITH A FY2017 PRE-DISASTER MITIGATION PLANNING (PDMC) GRANT

WHEREAS, Suffolk County and its towns and villages have experienced numerous natural and man-made losses resulting in three (3) declared disasters costing billions of dollars in municipal disaster aid since 2014 and according to the National Flood Insurance Program, Suffolk County ranks among the top counties within New York State in repetitive losses; and

WHEREAS, it is the desire of the County of Suffolk and all municipalities to fully conform with the Disaster Mitigation Act of 2000, which calls for each political subdivision within the United States to have a pre-approved mitigation plan prior to federal mitigation fund awards; and

WHEREAS, the current approved Suffolk County Hazard Mitigation Plan expired in June 2019; and

WHEREAS, Resolution No. 697-2019 accepted and appropriated 75% federal pass-through grant funds from the NYS Division of Homeland Security through its Office of Emergency Management in the amount of \$300,000 to the Department of Fire, Rescue, and Emergency Services for a PDM Planning Grant to update the existing Pre-Disaster Hazard Mitigation Plan; and

WHEREAS, this PDM Planning Grant is for a four (4) year period beginning October 12, 2017 through March 22, 2021; and

WHEREAS, this grant provided funding to engage in the planning process and produce a local multi-jurisdictional mitigation plan satisfying the requirements of 44 CFR Part 201 for Suffolk County and all its local communities including the Towns of Babylon, Brookhaven, East Hampton, Huntington, Islip, Riverhead, Shelter Island, Smithtown, Southampton, and Southold; Villages of Amityville, Asharoken, Babylon, Belle Terre, Bellport, Brightwaters, Dering Harbor, East Hampton, Greenport, Head of the Harbor, Huntington Bay, Islandia, Lake Grove, Lloyd Harbor, Lindenhurst, Nissequogue, North Haven, Northport, Ocean Beach, Old Field, Patchogue, Poquott, Port Jefferson, Quogue, Sag Harbor, Saltaire, Shoreham, Southampton, The Branch, Westhampton Beach, and Westhampton Dunes; Unkechaug Nation; Shinnecock Nation; Suffolk County Water Authority; and

WHEREAS, these jurisdictions, with like planning objectives, formed a coalition and pooled their resources to create consistent mitigation strategies within the County; and

WHEREAS, this coalition completed a planning process that engaged the public, assessed the risk and vulnerability to the impacts of natural hazards, developed a mitigation strategy consistent with a set of uniform goals and objectives, and created a plan for implementing evaluating and revising this strategy; and

WHEREAS, FEMA approved the 2020 Suffolk County Multi-Jurisdictional Pre-Disaster Hazard Mitigation Plan on December 4, 2020 pending local adoption of this resolution; now, therefore be it

1st **RESOLVED**, that this Legislature being the lead agency under SEQRA and Chapter 279 of the Suffolk County Code, hereby determines that this resolution constitutes a Type II action; and be it further

2nd **RESOLVED**, that this Legislature adopts the 2020 Suffolk County Multi-Jurisdictional Pre-Disaster Hazard Mitigation Plan (the "Plan") as approved by FEMA on December 4, 2020 pending local adoption, and will execute the actions identified in the Plan that pertain to the county; and be it further

3rd **RESOLVED**, that Suffolk County will adhere to the adopted Plan to guide pre- and post-disaster mitigation of the hazards identified; and be it further


4th **RESOLVED**, that Suffolk County will coordinate the strategies identified in the Plan with other planning programs and mechanisms in the County; and be it further

5th **RESOLVED**, that Suffolk County will continue its support of the Mitigation Planning Committee as described in the Plan, help to promote and support the mitigation successes of all Plan participants, will incorporate mitigation planning as an integral part of government and partner operations; and be it further

6th **RESOLVED**, that Suffolk County will provide an update of the plan no less than every five years.

PLAN ASSESSMENT - Plan Strengths and Opportunities for Improvement

This section provides a discussion of the strengths of the plan document and identifies areas where these could be improved beyond minimum requirements.

Element A: Planning Process

Strengths

- The plan provides excellent documentation in Volume 1, the Annexes, and in the Appendices. Of particular note is the References Section, which complements nicely the full description of the agencies involved in the planning process and the role that they play in keeping the community safe. The agency descriptions, supported by the Resources Section that demonstrates every effort was made to consider outside resources when the update was being developed. In the plan itself there were also references to specific plans that provided input to the hazard mitigation plan.

Opportunity for Improvement

- No significant improvement to suggest

Element B: Hazard Identification and Risk Assessment

Strengths

- The plan goes into great depth on each of the hazards, often providing maps along with tables to describe the location of the risks.
- The profiles for severe storms and severe winter storms include multiple threats, like high winds, lightning, storms with heavy snow, sleet, etc. etc. In these profiles the probability of each of these threats is given and the percent change of an event in a given year is provided. This is an excellent way to help decision-makers understand that storms are weather events with multiple types of hazards embedded in them, which require separate consideration on what might be done to mitigate these distinct threats.

Opportunity for Improvement

- No significant improvement to suggest

Element C: Mitigation Strategy

Strengths

- The plan includes many substantive mitigation actions that address clearly articulated problems.
- The Capability Assessment of each jurisdiction went beyond providing a long list of capabilities. It also described in some depth most of the capabilities. This included a good description of each jurisdiction's participation in the National Flood Insurance Program.
- The plan includes tribal nations. Each provided the necessary assurances called for when tribal nations participate.
- Appendix H Mitigation Catalog – This is a very good addition to the plan. It not only lists the types of actions that governments can take (by Hazard), it lists actions individual and

corporations can take. This help reinforce that whole community can help in lowering risk and building resiliency.

Opportunity for Improvement

- Many of the towns and villages plan to reach out to property owners where flooding frequently occurs to provide information on mitigation, such as acquisition, elevation, and floodproofing. This presents an opportunity for the county to bring these municipalities together for the purpose of developing a common and effective approach with supporting handouts and/or PowerPoint slides. The state and FEMA Region 2 may be able to support this effort by attending meetings or providing material.
- The plan in describing the capabilities of each jurisdiction does an excellent job in describing how controlling and lowering risks. It is clear an integrated approach does exist and the plan does cite some specific plans in describing vulnerabilities (e.g. Lake Ronkonkoma Clean Lakes Study on page 5.4.15-9). The plan would be improved if a succinct table were included that listed all the specific plans reviewed in one place, and any actions if appropriate that will be taken to strengthen the integrated approach already being taken. The table listing plans reviewed in Section 3.4 was a list of the types of plans reviewed.
- The formatting of tables where actions, with narrow columns design to contain a few words on the problem being addressed, made it necessary to expend a single row in the table to multiple pages in some cases. A reformatting of these tables would be appropriate when the plan is next updated. The solution is not to have the information shortened to fit the table, which the plan did not do, but to change the formatting of the table. [Appendix G has a similar issue with its format.]
